COURSE DESCRIPTION

'Understanding Diversity and Ally Development' is a certification workshop series, an initiative taken by the Graduate Ally Coalition (GAC) at UC Davis. At UCD, 40% of grad students belong to underrepresented communities. This course prepares graduate students to undertake the crucial work of making diversity meaningful and active in the everydayness of their professional lives, and starting from wherever they are. The course provides the tools to analyze multiple forms of oppression and the historical knowledge to make sense of the maintenance of oppression in the contemporary US. It supports graduate students to develop a set of interactive, pedagogic, and experiential principles that will allow them to make more conscious choices about their actions, to exercise self-critique, and to participate in educational communities with a more sophisticated understanding of equity and of the changes they can undertake to work for research and learning environments.

Designed as a 4-tier series, the first 2 workshops will focus on the conceptual foundations necessary to understand diversity and systemic oppressions in meaningful and relevant ways. They also examine everyday practices that translate the diverse community and on how to implement 'Principles of Community' document into action. The second half of this workshop series will focus on increasing awareness of social justice training, defined as the understanding of the dynamics and social inequality that result in some groups having privilege, status and access whereas other groups are disadvantaged, oppressed and denied access. Group participants will expand their understanding of the effects of social group memberships on their own experiences of disadvantage and privilege. They will learn how to become an ally in an action- and change-oriented series of participatory and interactive exercises that we aim to share during Social Justice, Ally Development and Bystander Intervention workshops.

LEARNING OBJECTIVESS

- 1) To enhance awareness of graduate students to the facets of being part of a diverse community and on social justice.
- 2) To provide graduate students the tools to serve as better allies to their peers and to share best practices in Ally Development
- 3) Examine bystander dynamics, develop strategies for intervention, and examine leadership traits of an ally

For that reason, participation in the "process" and the interaction of experience with self-reflection is core to the learning in this seminar.

Frameworks for Social Justice in Education: Examining Privileges and Ally Development Module C
